Roper St. Francis Foundation – Gift-in-Kind Details & Instructions

Definition: Gifts-in-kind are gifts of property that are voluntarily transferred by a donor to the Roper St. Francis Foundation without compensation. These gifts may include equipment, vehicles, materials, supplies, artwork, and other personal property a donor might give to Roper St. Francis.

Gifts of services are not considered to be a tax-deductible contribution.

In-Kind Donations up to \$5,000:

If the donation is from \$500 to \$4,999.99, an IRS Form 8283 will need to be filed with the donor's tax return to claim the deduction. Please consult with your tax advisor.

In-Kind Donations of \$5,000 and above:

If the donation is \$5,000 or more, an IRS Form 8283, signed by an authorized appraiser, is required by the IRS and the Foundation, in addition to a copy of the appraisal.

In-Kind Donations of Motor Vehicles, Boats and Airplanes:

In addition to the completed Gift-in-Kind Form, please provide the Foundation with a copy of the Vehicle Certificate of Title (front and back), copy of the Bill of Sale, IRS authorized appraisal (if value is over \$5,000.00), and IRS Form 1098-C and IRS Form 8283.
